MINUTES

CALL TO ORDER: Vice Chairman Hatch called the meeting to order at 6:30 p.m.

PLEDGE OF ALLEGIANCE: Vice Chairman Hatch led the Pledge of Allegiance.

SELECTMEN PRESENT / QUORUM: Vice Chairman Steve Hatch, Randy Clark, Chester Nutting, and Joe Massey. Also present Town Manager James Rhodes, Town Clerk Pamela Violette, and Police Officer Jeff Belanger. Chairman Towne was absent.

COMMENTS / QUESTIONS FROM THE PUBLIC CONCERNING MATTERS NOT RELATED TO ITEMS ON THE AGENDA. The Board's rules of procedure have imposed a 15-minute total time limit.

Spirit of America Foundation representative, Bruce Flaherty, provided information to the Board of Selectmen about Spirit of America. Spirit of America is a public charity that was established to encourage and promote volunteerism and provides guidance to public officials in the process of recognizing local individuals, organizations and projects for exemplary altruism or community service.

Ken Abbott, Clinton resident, asked about the update of land use violations. Mr. Abbott does not think the Town is getting enough bang for the buck. Town Manager Rhodes advised Mr. Abbot CEO Sharkey provided the Board with an update at the February 26, 2008 meeting and the list can be obtained at the Town Office.

Mr. Abbott asked why the Town roads were not posted. Town Manager Rhodes said the Town of Clinton does not have an ordinance to allow posting the roads. Selectman Massey said he would like to see an ordinance in place.

Approval of Selectmen's Minutes – February 26, 2008.

Selectman Clark moved the Board approve the minutes of the February 26, 2008 meeting. Second by Selectman Nutting. Vote 4 in favor.

March 11, 2008 Selectmen Minutes

Resolution 08-03: Budget Committee's Submission of the FY 08 / 09 Recommended Municipal Budget.

Budget Committee Chairman Phil McCarthy provided the Board with an overview of the proposed FY 2008/2009 Municipal Budget and highlighted changes recommended by the Budget Committee.

Vice Chairman Hatch read Resolution 08-03 and thanked the Budget Committee for doing an excellent job.

Selectman Clark moved the Board adopt Resolution 08-03, seconded by Selectman Nutting. Vote 4 in favor.

Board approval of Tax Acquired Property Bid Ad and Minimum Bid for Each Tax Acquired Property.

Selectman Clark moved the Board approve the Tax Acquired Property Bid Ad and Minimum Bids, seconded by Selectman Nutting. All in favor.

Central Maine Power Pole Permit Application.

Selectman Clark moved the Board table to the March 25, 2008 meeting the Central Maine Power Pole Permit Application for Church Street pending additional information, second by Selectman Nutting. Vote 4-0

DISCUSSION ITEMS:

Appeals Board Decision regarding Bruce Salsbury's Appeal of denied Application for Building Permit. – No action. Provided memo for information.

Proposed FY 08 / 09 Municipal Budget – No action. Provided time schedule for information.

SUPPLEMENTS AND ABATEMENTS:

Selectman Massey moved the Board of Assessors approve abatement numbers 29 through 46 for a total of \$5,878.05 for personal property due to bankruptcy, business closed, deceased tax payer, or missing tax payer, second by Selectman Nutting. Vote 3 in favor, 1 abstained (Clark), motioned passed.

TOWN MANAGER'S REPORT:

Expense / Revenue Report - Town Manager Rhodes reported General Assistance is overspent by \$6,490 for heating assistance, \$924 for electricity, and \$3,376 for rental assistance. Overall, 67.95% of the budget has been spent. Last year at this time 70.97% was spent and the year before 70.79%.

Upon The Application of **Central Maine Power Company and VERIZON NEW ENGLAND TELEPHONE COMPANY** dated February 21, 2008, asking for permission, in accordance with law, to construct and maintain poles, buried cables, conduits and transformers, together with attached facilities and appurtenances over, under, along or across certain highways and public roads in the location described in said application, permission is hereby given to construct, reconstruct, maintain and relocate in substantially the same location, said facilities and appurtenances in the Town of **CLINTON**, approximately located as follows:

- 1. Starting Point: MAIN STREET
- 2. Road (State & CMP): CHURCH STREET
- 3. Direction: NORTHERLY


